- **Robin and Ian Macleod (applicant/owners)** seek a variance under MGL Ch. 40A §10 and Section 300-2.1 "Frontage" definition of the Medfield Zoning Bylaw for the use of a shared driveway because the newly subdivided parcel lacks vehicular access to the existing home. The parcel is also located on a scenic road and owners are trying to minimize disturbance to historic stone wall and scenic trees. The property is located at 227 North St; Assessors' Map 57 Lot 24; RT Zoning District with portions of it on the Primary and Secondary Aquifer Overlay. Note: this parcel was divided through an ANR on the 06/26/23 Planning Board Hearing.
