The property is located at 6 Belknap Rd; Assessors' Map 44 Lot 095; RS Zoning District with no Aquifer Protection Overlay.

- **1 Hale Pl - Jonathan Press & Natalie Raffol** - (applicant/owners) seek a special permit under MGL Chpt. 40A §9 and/or §6 and/or Medfield Zoning Bylaw §300-6.2(G)(4) for the proposed work consisting of a porch which would be located no closer than 25.3' to the front setback line where 30' is required. The property is located at 1 Hale Pl; Assessors' Map 43 Lot 119; RS Zoning District with a Secondary Aquifer Protection Overlay.
