Discussion Items (Potential Votes)

1. Discuss Medfield State Hospital and potential vote to call a Special Town Meeting on Tuesday, June 21, 2022

Ms. Murphy supports holding the meeting on June 21. If the LDA (land disposition agreement) continues to move with the dialogue we are having with Trinity, it is imperative we get the support now knowing that the meeting is one of the criteria Trinity needs to move on sooner than later. There are a lot of opportunities for the public to ask questions. When we look at the Medfield State Hospital Master Plan, we're driving toward what the Town is looking forward to restoring and maintaining the building and keep open space. Trinity is a good partner. They understand how to use tax credits. They have many other extremely successful developments. Everything we have heard about them has been very good. Partnering with Trinity will allow us to keep those structures and keep the charm.

Mr. Peterson agrees with Ms. Murphy. We need to keep the process moving. Trinity has given the Town the proposal the Town said it wanted. We had a very glaring second proposal that offered the Town a lot of money, but it was not what the Town said they wanted. If you want to tear all the buildings down and get a pocket full of money, then you can go that route, but the Town said they wanted reuse of the existing buildings and we're getting the number of units we wanted. The Town will make money every year as we will net \$500,000 to \$700,000 in extra property taxes over the cost of providing services there.

MSH Development Committee Chair Todd Trehubenko said we continue to make good progress Trinity. Residents will have an opportunity to read online report reviews as well as peer reviews from Town departments and committees well before Town Meeting in the Trinity section on the Medfield State Hospital website. He provided background on what the Town's peer reviews are and which firms are performing them.

Mr. Murby said while we don't yet have an LDA, we continue to make progress. The LDA will be available before the meeting on June 21. He recommended to watch for information coming from Brandie Erb and Lucille Fisher.

MOTION: Mr. Peterson moved to call a Special Town Meeting on Tuesday, June 21, 2022 for the purposes of dealing with the Medfield State Hospital development. Ms. Murphy seconded.

Ms. Trierweiler recommended the BOS invite Scott McDermott to the next meeting as well as reduce the size of the quorum to hold a meeting under the Covid regulations. She said there is a process for the quorum reduction. It needs to be advertised for seven days before the next BOS meeting to have the discussion.
