Dear Members of the Medfield Zoning Board of Appeals,

As we discussed at our last appearance before you in the hearing of the comprehensive permit application for The Rosebay at Medfield, comprehensive permit hearings are expected to end within 180 days from the date of opening the hearing, but can be extended with the written consent of the applicant (please see 760 CMR 56.05(3)).

Accordingly, the applicant hereby consents to the extension of the hearing for up to 60 days beyond the initial 180-day period prescribed in 760 CMR 56.05(3), as may be necessary for the Board to conduct a reasonable review of our application.

We look forward to the continuance of our hearing, and presenting our plan for stormwater management at our appearance scheduled for next Wednesday evening.
